### **Board Member Comments:**

- Faro praised Ms. Upton and described her as an incredible human being. He discussed the District finishing the 2023 2024 fiscal year with a net surplus of \$33,000. He thanked Ryan McMahon and team for their work to obtain grants and increase revenue. He discussed the upcoming vote to institute a sinking fund and explained its benefit to the general fund.
- Heikka asked if the audit findings would be available publicly to help combat misinformation in the community related to the District's finances. She praised Krista Hendrix for another clean audit. She also praised the District for finishing for the second year in a row with a surplus. Lastly, she welcomed the new Student Board Members.
- Prior offered her condolences to Ms. Upton's family. She encouraged the community to attend the FFA Hog Roast.
- Gutierrez discussed the budget and the audit findings. She also discussed the need for a sinking fund to help invest in the District's assets. She discussed the District's 11% Fund Balance and how it exceeds the District's goal of 10% and the State's requirements. She also discussed the desire to not hold resources that could be used to pay staff. She thanked Krista Hendrix for another clean audit and her financial leadership. She thanked Paddock Elementary for their Body+ program. She also offered her condolences to Ms. Upton's family and welcomed the Student Board Members.
- Meray offered her sympathies to Ms. Upton's family and expressed her gratitude for her service and described her as a treasured colleague. She praised the 7/8 grade Volleyball Team for supporting one another and credited the coaches for creating a supportive atmosphere. She also praised the student spectators for their support for the teams. She announced a Student Tech Forum at the Michigan Capitol in December.
- Cislo thanked the Girls' Swim Team for inviting the Board to their Educator's Appreciation Night. He also discussed the 11% Fund Balance and the District's balancing between our accountant's desire for 20% and the District's desire to pay staff as much as possible. He also stressed the importance of strong schools and the impact of such on the market value of homes in the community.
